1. Please **read all instructions carefully and keep in a safe place** so you can refer to them while preparing for you procedure.
2. You will receive medication to sedate you during your procedure. You are not permitted, by law, to drive until the next day. **Please make arrangements for a friend or family member to accompany you and to transport you home.** If you do not make arrangements for someone to drive you home, your procedure will not be done. The physicians and staff of the Endoscopy Centers are not willing to take that risk. Taxi cabs are only acceptable if you are accompanied.
3. **Please fill out the list of your current medications and bring it with you on the day of the procedure.**
4. State law requires that we ask if you have executed an **Advanced Medical Directive**, otherwise known as a **Living Will** (a legal form in which you designate someone to make medical decisions for you, if you should become unable to do so). You **do not need** to bring it with you. While the Endoscopy Center does not honor Advanced Directives, the staff will document information you give about your Advanced Directive in order to provide it to the hospital if a need arises. We can also provide you with information about Living Wills, if you so desire.
5. You will be given a patient belongings bag for your clothes, when you arrive for your procedure. **Do not wear or bring jewelry and/or valuables with you.** You may wish to bring a pair of slippers or socks to wear that day. Your belongings will be placed on your assigned stretcher and will be with you at all times.

**ENTRANCE TO BUILDINGS**

The **entrances to both centers are in the rear of the buildings.** Please do not use either of the side emergency exits. **Note which building your procedure is scheduled in (above) and look for the building number (477 or 473).**

PLEASE NOTE: You and/or your insurance company will be receiving a bill from the Endoscopy Center for the use of the facility (as you may have when you may have had a procedure performed at the hospital and you received a separate bill from them). This is separate from the physician's bill for services rendered. If you have any questions, please do not hesitate to contact us.
